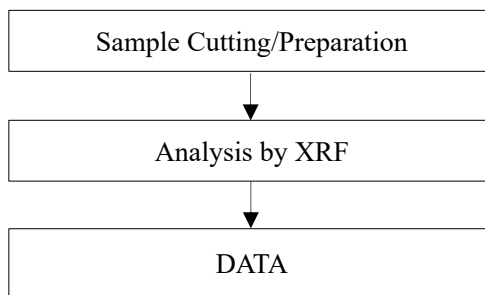

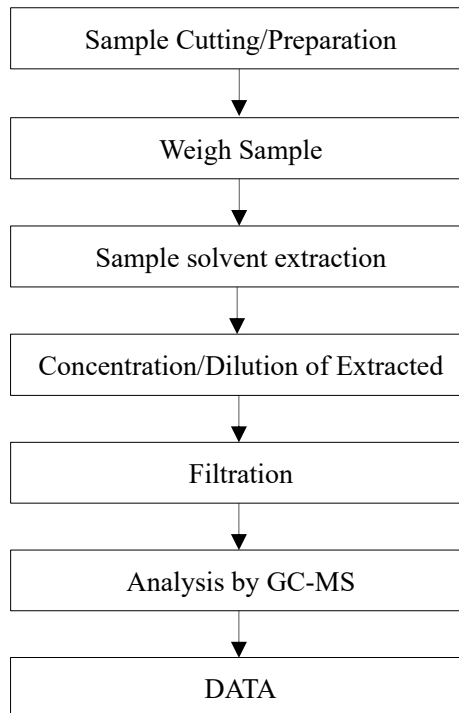

Test Flow Chart of Phthalates



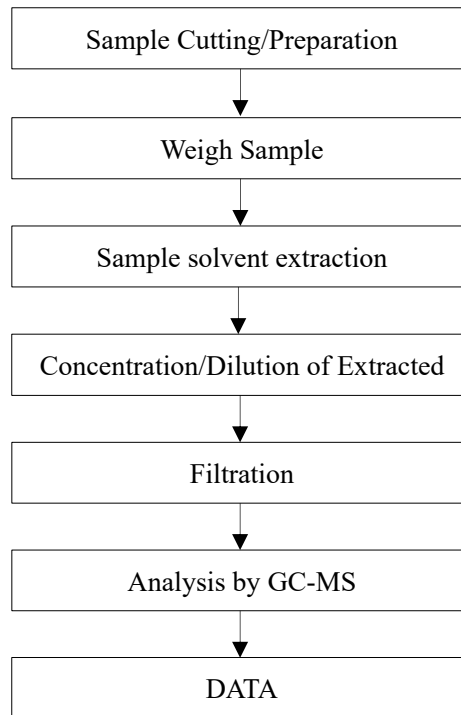

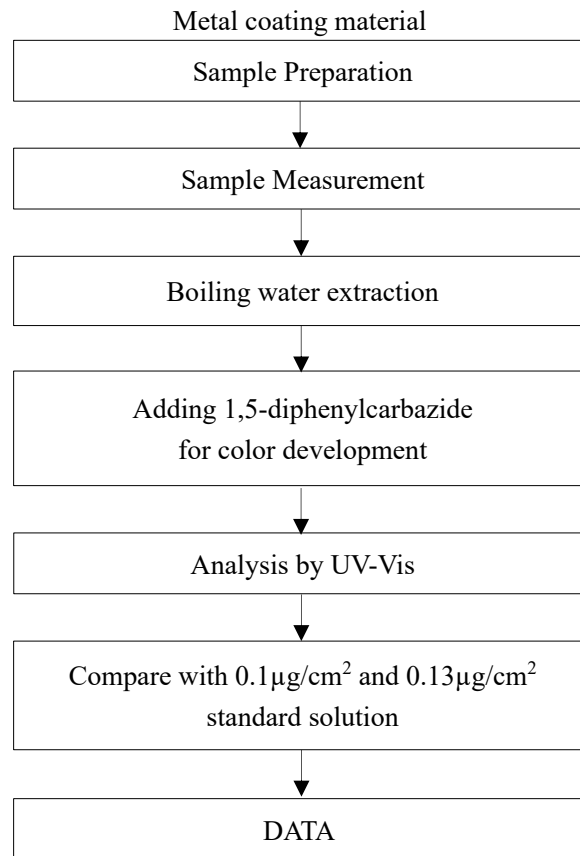

Test Flow Chart of Hexavalent Chromium (Cr⁶⁺)



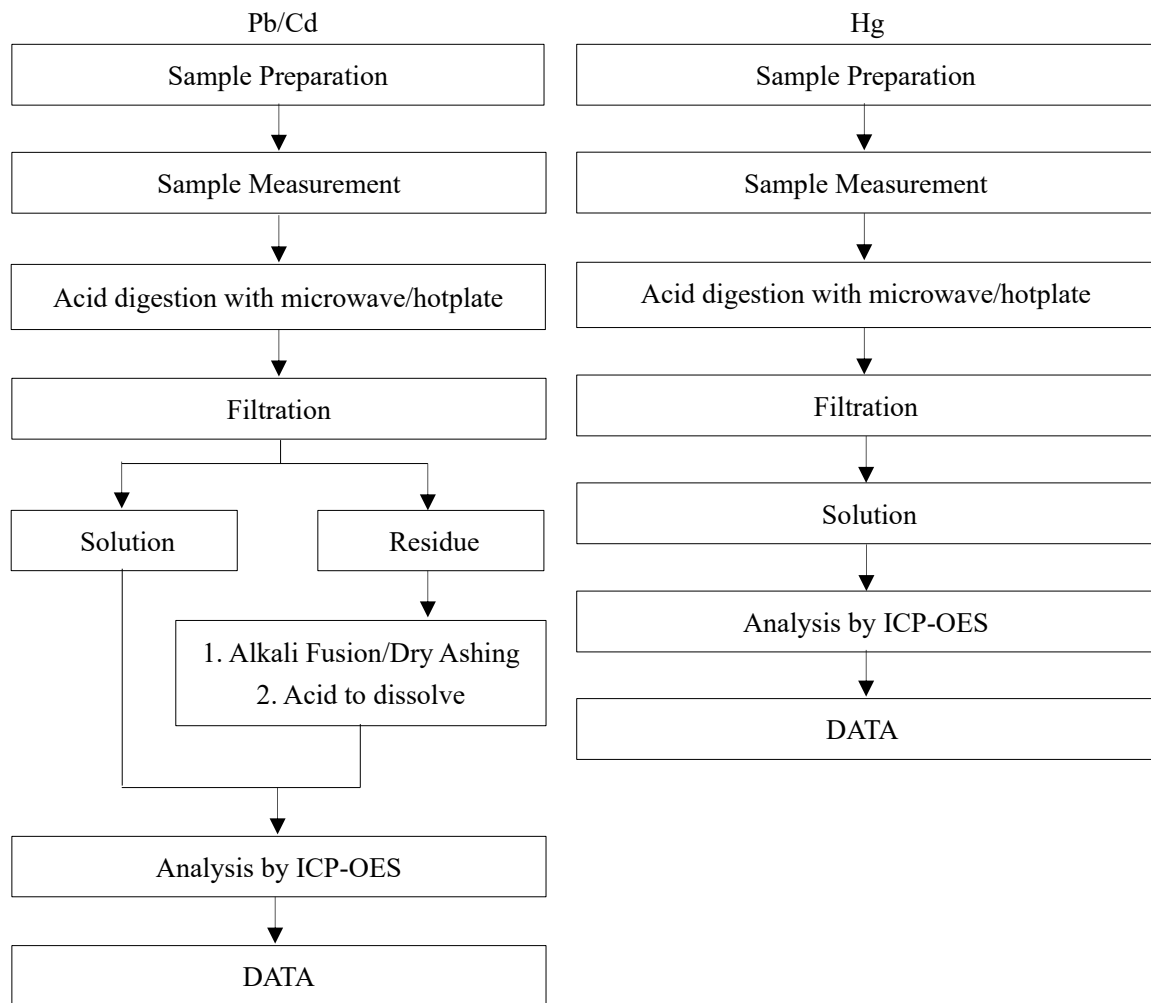

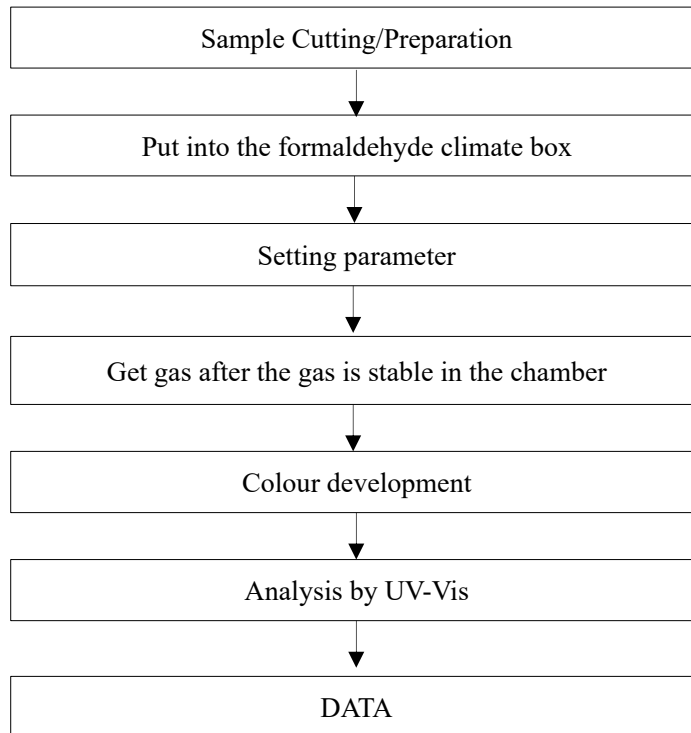
Test Flow Chart of Lead, Cadmium and Mercury



These sample were dissolved totally by pre-conditioning method according to above flow chart

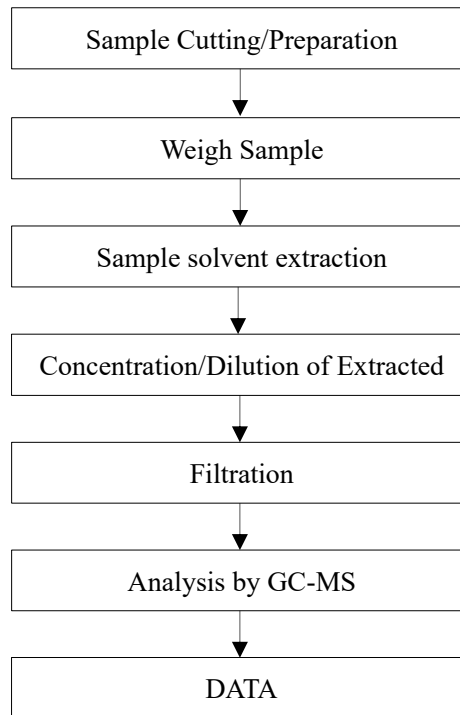
