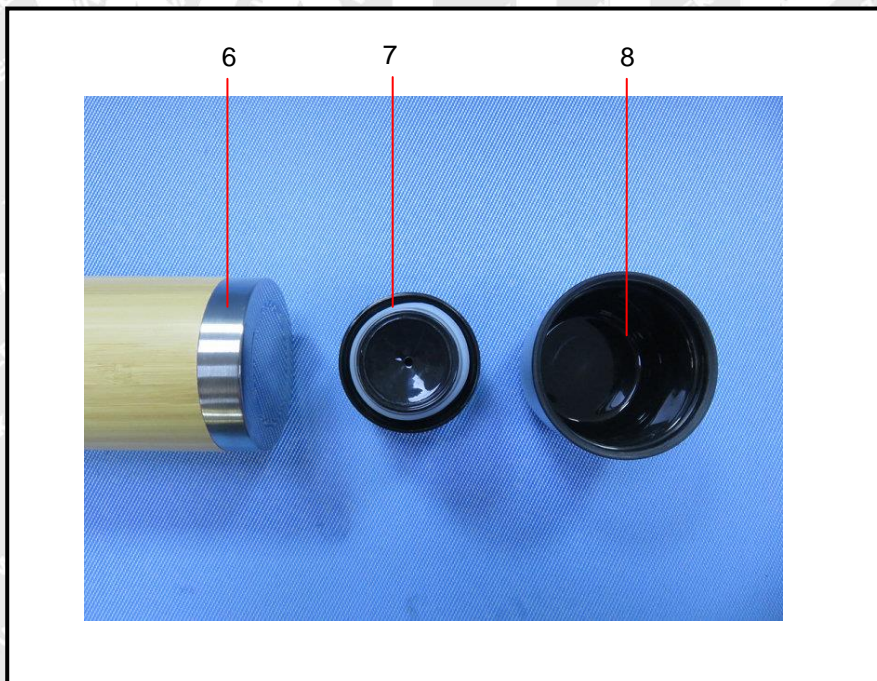
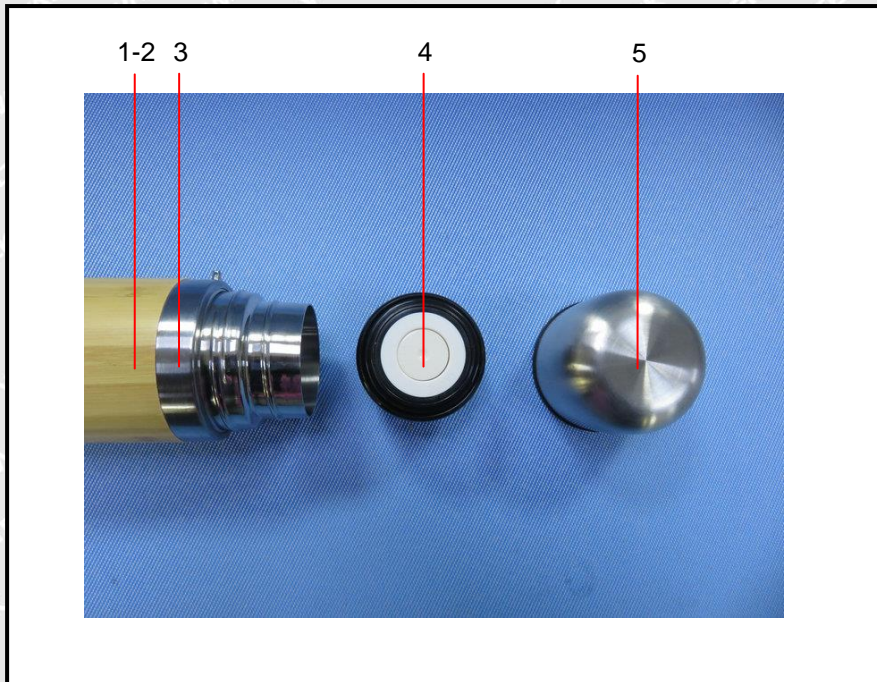
- No.1: Brown-yellow wooden shell

- No.9: Silvery metal inside walls of the cup

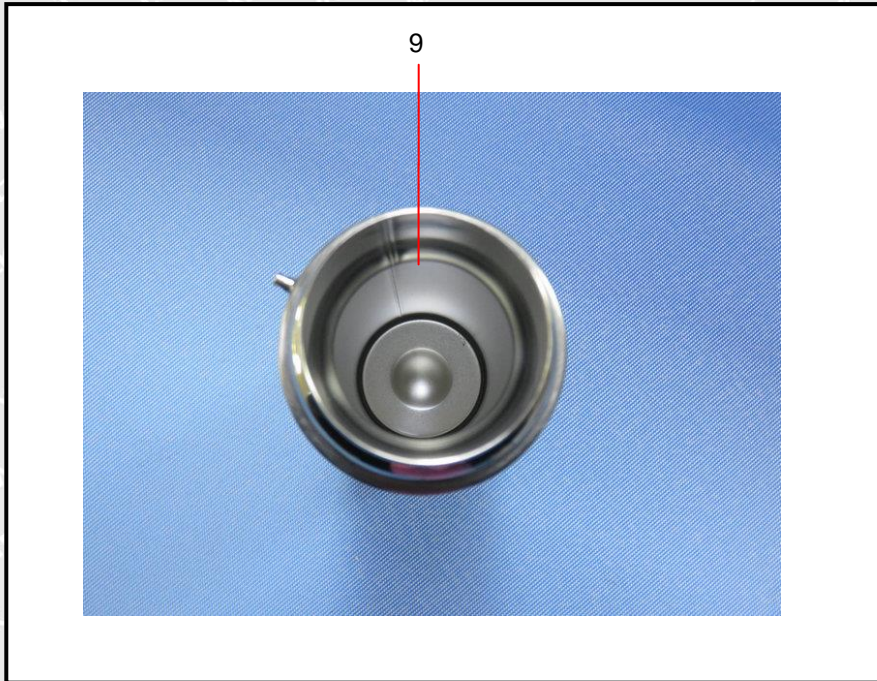
