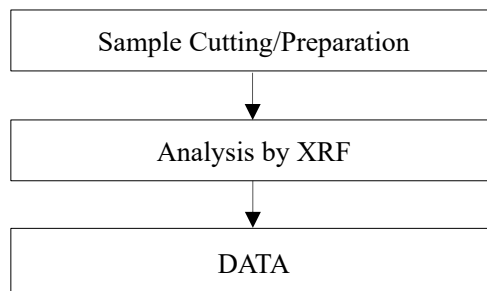

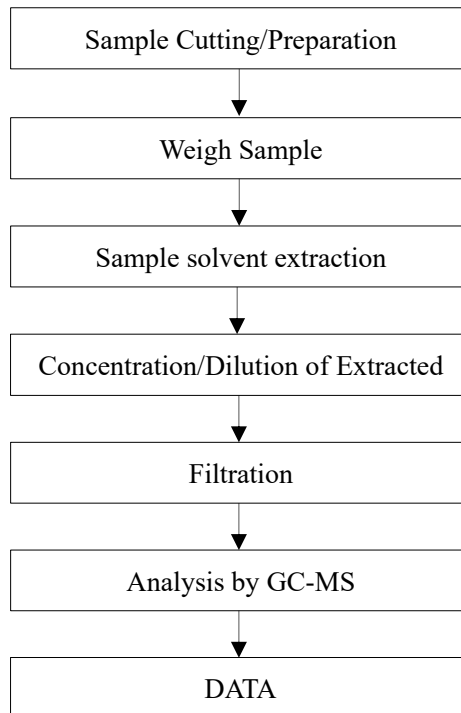

Test Flow Chart of Phthalates



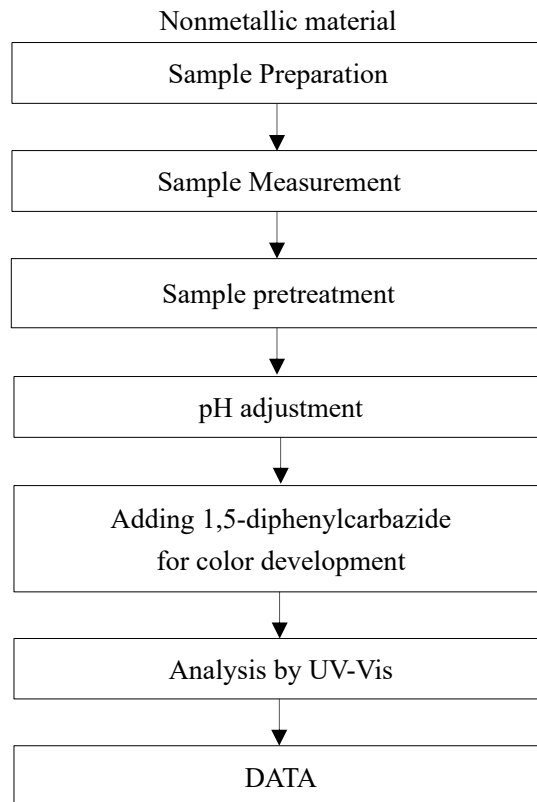

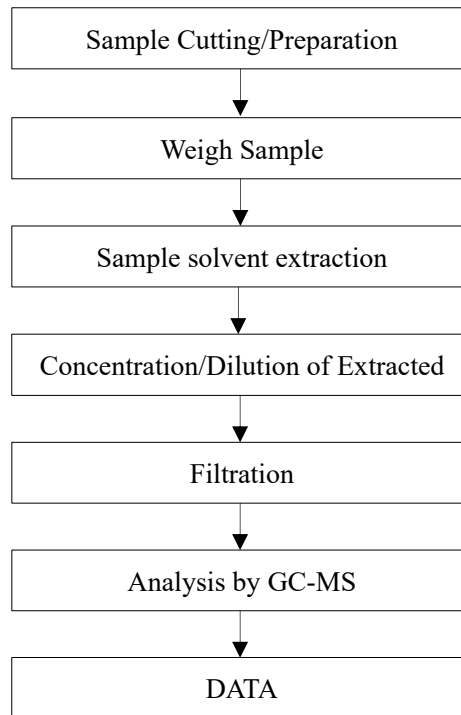

Test Flow Chart of Hexavalent Chromium (Cr⁶⁺)



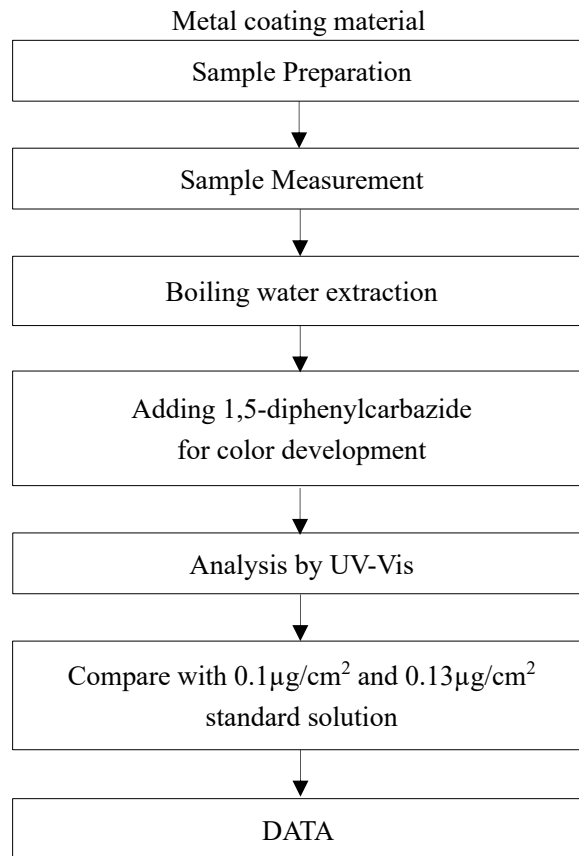

Test Flow Chart of PBBs and PBDEs



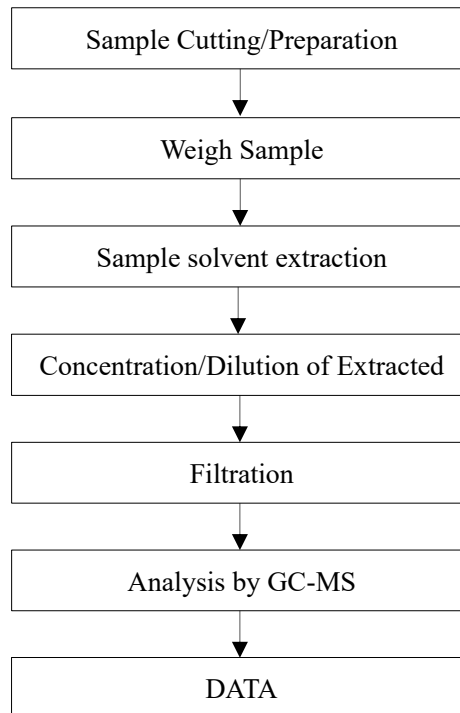

Test Flow Chart of Hexavalent Chromium (Cr⁶⁺)



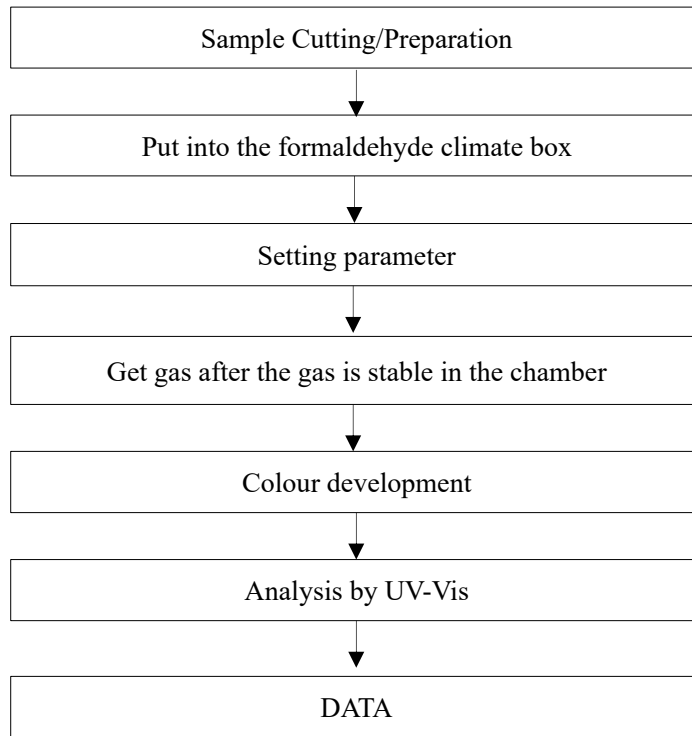
