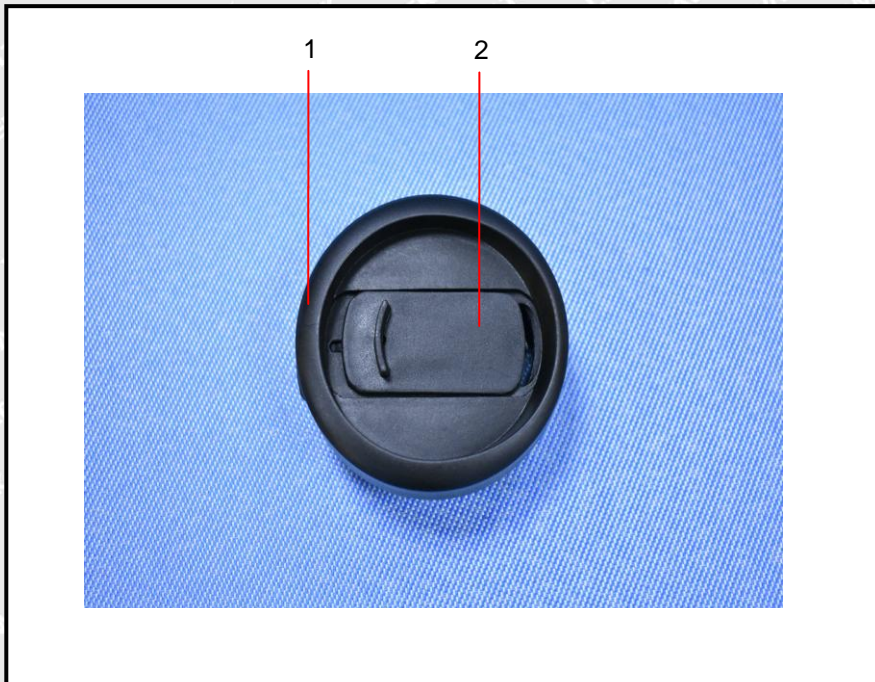

- No.8: Silvery metal shell

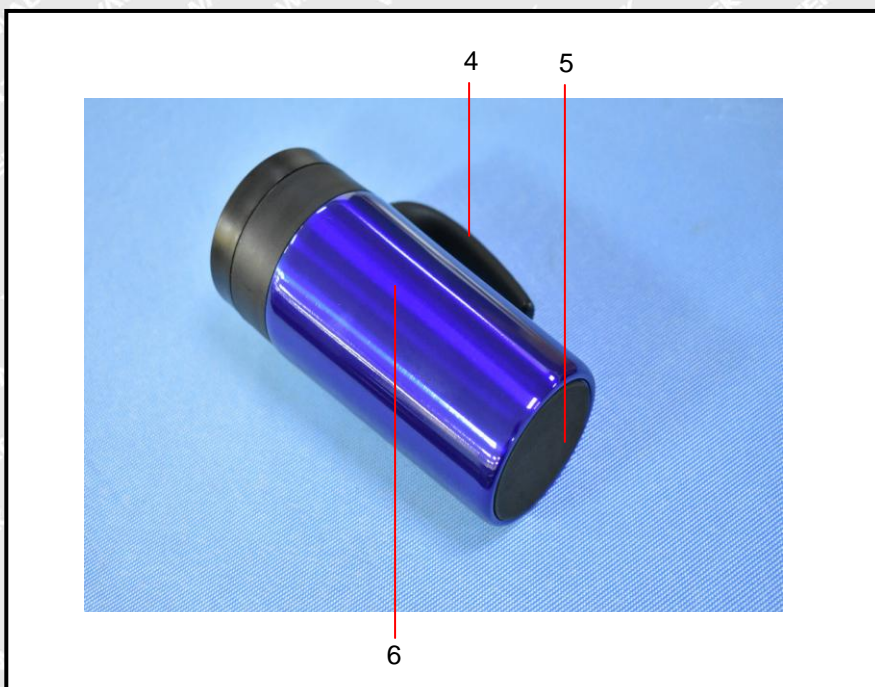
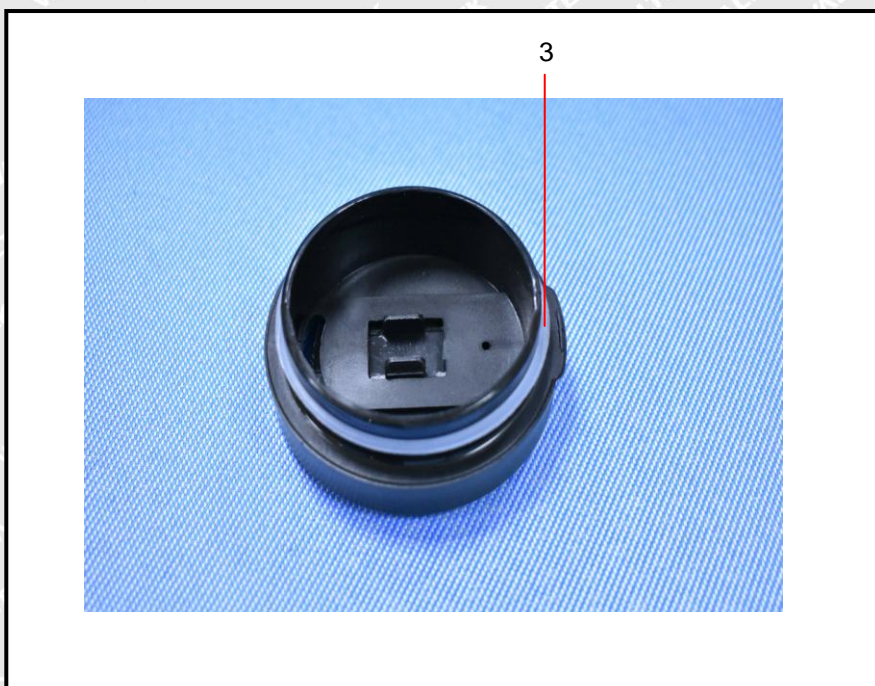

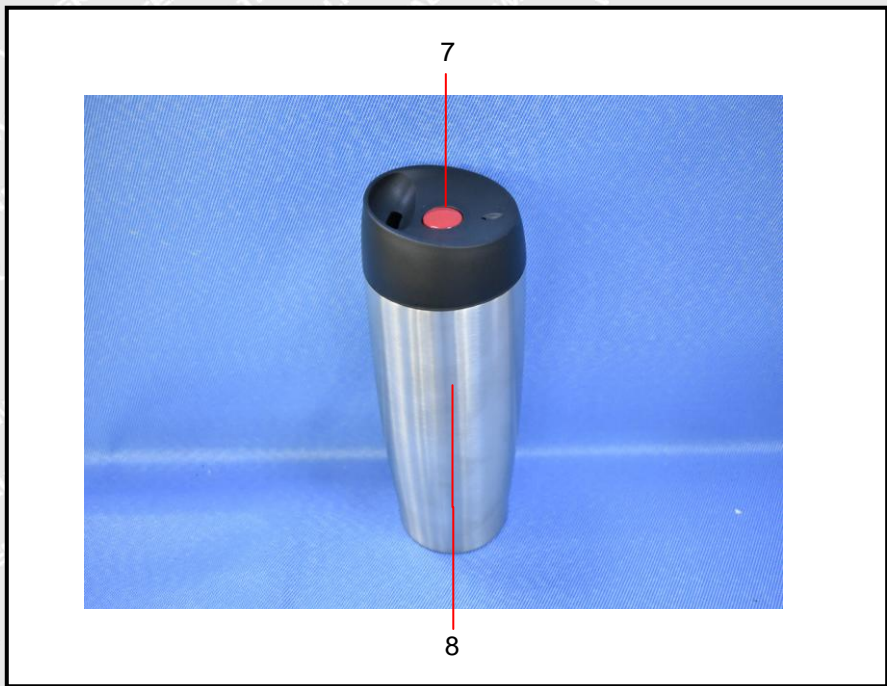
