

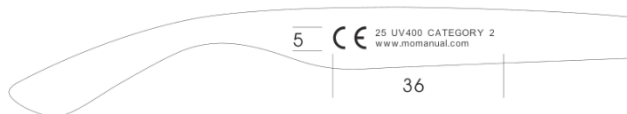

Once stained, please clean it up in time. In addition, if you sweat a lot, you should wipe it clean in time.

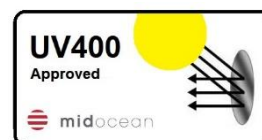
